1) **Good communication skills**

also true in the drafting of contracts, which requires the reconciliation of opposing needs: a Smart Working Lawyer will never lend himself to the drafting of a halter or illegal contract in favour of his client. This concerns honesty, which I do not list as a particular quality, because it is presupposed in the lawyer's professional figure.

3) Analytical and synthesis skills

The study of a legal practice, both procedural and contractual, involves the examination of large amounts of documents and information, which must then be distilled into something manageable, logical and understandable even for the non-jurist assisted.

Furthermore, every judge appreciates the incisive and concise expository style, without redundant sentences, in the defense acts, especially when the decision of a lawsuit involves the choice between several reasonable solutions because non-univocal jurisprudential precedents.

A Smart Working Lawyer must therefore have a good capacity for analysis but never be verbose, because what impresses the judge – and also the contractual counterpart in the drafting of a contract – is the synthesis, which is expressed in essential and incisive sentences.

4) Know how to search

The ability to do research quickly and effectively, now that the Internet and online databases are available to everyone, is essential to understand the client and his needs even beyond the specific case, in order to prepare an effective legal strategy.

This is because the preparation of an effective strategy or the drafting of a contract requires understanding and processing large amounts of information.

5) **Psychology and empathy**

The Smart Working Lawyer overcomes the cliché that an excellent lawyer is the one who manages not to get involved in emotions, remaining imperturbable to the confidences of the client, because he knows psychology: to achieve success, in any field, it is necessary to work with emotional intelligence, knowing how to recognize the character traits of each interlocutor, in order to manage their emotions.

This is because emotions are adaptive, which is functional to organize our thinking. Each of us has specific emotional skills, which help us understand what we need to pay attention to because it is important for us and for our client.

Engaging with empathy creates lasting sales. And this is true not only in digital marketing. All of us, in any industry, create relationships to sell and human relationships are the foundation of any sale. The focus is on creating a relationship of trust.

6) **Courage and perseverance**

Studying to become a lawyer required a lot of perseverance and commitment, which is why the smart working lawyer applies the same commitment and tenacity in the profession.
